



The battle to get the CVS up and running has been ongoing in 2016. February 2017 marks 5 years since the Minister agreed to the scheme. T. Thompson spoke of the efforts of Mr. J Chummun of the RMS in implementing the scheme and getting it to where it is at this point in time.

T. Thompson spoke of the VSWG's efforts, stating that the Suspension Modification Manual had been held up since early in the year but, due to the Minister's efforts it has now been released.

T. Thompson also spoke of the value of the ACMC, stating that the organisation is made up of over 600 clubs comprising over 80,000 individual members. As a result of these numbers, the ACMC is able to positively influence the NSW Government with regard to classic vehicle matters.

Terry spoke of the value of having a Minister who is committed to the Classic Vehicle Movement.

T. Thompson advised that P. Coggiola is now the Secretary of the AHMF. Terry implied that the value of the AHMF to the movement is unclear, at best.

T. Thompson spoke of the Concours event at Warwick Farm in 1971 when the CMC had only 29 member clubs and related stories from that time.

T. Thompson speculated on the future of the CMC stating that it is time to seek out younger committee members to learn the processes required to administer all aspects of the Council in the future.
