- T. Thompson reported:
- L. Gough has had liaison with various clubs, with letters of invitation being sent to eight clubs.

Judging Pool - T. Thompson (in T. Bebbington's absence)

T. Thompson reported:

- The Judging Pool is ready for the 2018 year with the first booking for the Vauxhall Owners Club 15th April.
- T. Thompson reported that this year's Concours at Shannons Sydney Classic will have different categories, including CVS vehicles and motorcycles. For the first time the motorcycles will be judged on Pit Lane, same as the cars.

National Motoring Heritage Day - 20th May 2018

T. Thompson reported that:

 Campbelltown Steam & Motor Museum Menangle; Museum of Fire; Wentworth Falls Lake; Fagan Park.
- K. De Luca is liaising with Hornsby Council with a view to a display at Fagan Park, Galston.

Shannons Sydney Classic – 12th August 2018

T. De Luca advised that the Application Form is on the CMC Website and are being handed out tonight.

- Area C Map needs to be redrawn and the number of vehicles may be less than previous years. Areas B and D will also be checked for spacing of vehicles. Allocations can't be commenced until the maps are final.
- Forms MUST be completed properly and signed by the President and Secretary. Tickets should be collected at the May Meeting to avoid postage costs and tickets being lost in the post.
- All British Day this year has been moved from August to 23rd September 2018.

AHMF - T. Thompson

T. Thompson reported:

This year's AGM could be in Adelaide in conjunction with the "Bay to Birdwood".
 T. Thompson encouraged delegates to consider Robert Shannon Foundation – not just for car restoration but other areas relating to Clubs as they could be worthy of a RSF Grant.

ACMC & VSWG & Road Safety Advisory Council - T. O'Donnell & T. Thompson

T. O'Donnell spoke about the RMS not accepting old engineering certificates. Problems arose making some owners having to get vehicles re-engineered. Meetings with Road Minister, Melinda Pavey and officials from the RMS ensued and bulletins were issued advising that our requests had been agreed to. The Certificate now is for the life of the vehicle and only changes need to be engineered. From the floor a vote of thanks to both Terry and Tony O'D for all their efforts.

Events & Tours - L. Titcume

L. Titcume reported that:

- Mudgee Tour 2-5 March 2018 including the Wellington Swap Meet, winery tour and Vintage Fair. Cabins have been reserved at the Riverside Caravan Park.
- Classic Yass Tour Saturday 3rd November 2018. Navigation Run Alpine Classic permission to close some roads in Yass and run a gymkhana.
- Planning is commencing for a 2021 trip to Europe and the UK hopefully including Goodwood and other venues –
 possibly a 26 day tour.

Matters of Affiliation - L. Gough

- The Mt Warning Historic Auto Club was proposed for Membership of the CMC at the November Meeting. A
 vote was taken and the Club was unanimously voted onto Council.
- The Glossodia Classic Vehicle Club has been put forward to the CMC Committee and is now recommended
 that the Club is suitable. Details were given to delegates. A vote was taken was taken and the Club was
 unanimously voted onto Council.
- L. Gough mentioned that there are 7 Clubs on the "outstanding" list who have not responded to the letter of offer.
- At the November Meeting, The Gluttons Car Club Broken Hill was mentioned as an interested Club. L. Gough will be conducting a teleconference with them tomorrow night.

General Business

- I. Andersen spoke about the CMC sub-committee that has been formed to investigate NRMA, covering the member and not the car, as is being done in other States.
 - Several sub-committee meetings have been held and lots of emails. Senior people in the NRMA have been approached and information has been collated and they are trying to ascertain the corporate structure of the NRMA. We plan to go direct to senior executives and then approach the Board Members individually with data that has been collated over previous months/years. There are 100,000 paid up members between CMC & ACMC we can then influence 500,000 people. The SA scheme can't be done online. NRMA membership will be lost if transferring from NRMA. NRMA will attend to breakdowns in NSW. Cost of SA Scheme is from \$99 -\$190 p.a.
- T. Thompson mentioned the NRMA is known more these days as a Travel Agent rather than Road Service.
- P. Marshall Cormack addressed the meeting in relation to NMHD in 2018. Patrick advised that Michael
 Lipscombe will be running the event next year. Registrations are to be made online and no pre-booking
 necessary. He also mentioned that The Yass Classic was a great event, including billy-kart racing down
 the hill.
- D. Fletcher (Morgan Club) the Club is celebrating 60 years this year and will display on Pit Lane at SSC and the Diamond Muster at Bathurst in October.

- D. Livian (Mustang Owners) thanks to Terry & Tony for getting LHD-RHD sorted out. All American Day at Castle Hill has been running for many years. This year was the last year at Castle Towers thanks to everyone for the support. A new shopping centre venue is required. Last year \$10,000 was presented to Westmead Hospital, this year we have \$8,500 for the Hospital. Congratulations to all involved.
- T. Amos (Isuzu Club) the Club is celebrating 50 years this year and on 11th March 2018 there will be an Open Day at Linwood House, Guildford with stalls, music etc. Other Clubs are invited to attend.
- P. Marshall-Cormack gave a reminder about reflectors on vehicles/trailers etc. Congratulations to
 Macquarie Towns Motorcycle Club one of their members had one on his bike & one on his helmet. T.
 Thompson advised that Macquarie Towns Motorcycle Club had the highest number of vehicles on
 HCRS (over 500) and 280 vehicles in the Alfa Romeo Club.
- D. Trew (Classic Falcon Owners Club) again showed the folders he is producing for HCRS/Log Book paperwork. There is now an updated version costing \$5 each for 25 copies and the cost goes down the more you order. Your Club's logo can be included on the folder.
- D. Nicholls (Aust. Porsche 356 Register) David is the Club Registrar and 2 members were found to be "doing the wrong thing" re registration and 3rd party issues and paperwork was not being done through the Club Registrar. He contacted the RMS re HCRS paperwork and advised that it wasn't being done through the Club. Unfortunately the RMS couldn't locate the paperwork they didn't accept incomplete forms but it does give the Club permission to deal with their members as they feel necessary. David feels that the RMS has lost control of the Log Book Trial.
- T. O'Donnell spoke about why the Log Book Trial wasn't a permanent thing. Police have raised the issue
 of people abusing the system. When the trial ended it was easier to let it continue on for another 2
 years trial. The Police feel people may be rorting the system. Apparently the RMS computer system
 can't cope with newer requirements.
- T. Thompson Road Safety Advisory Meeting the chief Policeman advised they are currently scanning more than one million plates per day picks up not just registration but all other matters including child support etc! The same Policeman spoke about a conference in Texas that he attended Texas has no laws about drink driving/drugs/speed limits etc. but 3 times as many people will die on the roads there.

Acronyms which may appear in the report are explained as follows:

ACMC - Australian Confederation of Motor Clubs

A group of 8 motoring enthusiast councils etc. representing most areas of classic motoring. The ACMC was formed to fill the need for motoring enthusiasts to have a combined, and therefore stronger, voice when dealing with Government Departments in relation to the motoring enthusiast movement. ACMC is the signatory to the MoU for the CVS.

AHMF - Australian Historic Motoring Federation

National peak body for historic motoring enthusiasts

ANSMA - Australian National Street Machine Association

Peak body for street machines.

ASIC - Australian Securities & Investments Commission

Enforces company and financial services laws to protect consumers, investors and creditors; regulates and informs the public on these matters.

ASRF - Australian Street Rod Federation

Peak body for street (hot) rods.

CVS - Classic Vehicle Scheme

Conditional registration for modified vehicles 30 years old and older. Contains a 60-day logbook option.

HVS (Old HCRS) - Historic Vehicle Scheme Conditional registration for unmodified vehicles 30 years old and older. Contains a 60-day logbook option.

NMHD - National Motoring Heritage Day

An initiative of the AHMF whereby motoring enthusiasts are encouraged to be out on the roads and attending various events around the country, in order to keep the interest in our vehicles alive and thriving. NSW leads the way in this event.

RSF - Robert Shannon Foundation

A foundation dedicated to assisting motor vehicle restoration and other related projects, (for under 30-year old club members) by way of annual grants.

RSAC - Road Safety Advisory Council

SSC - Shannons Sydney Classic

The CMC's premier event; held in August each year at Sydney Motorsport Park for clubs to display their vehicles and compete for Concours trophies.

SMSP - Sydney Motorsport Park

SSC main event venue.

VSWG - Vehicle Standards Working Group

Came out of discussions by the ACMC with the NSW State Government, which then formed the group to assist with motoring standards for classic vehicles. The ACMC and CMC are well represented on this panel.
